

RESOLUTION TO CENSURE STATE REPRESENTATIVE MORGAN MEYER FOR IMMEDIATE PRESS RELEASE

WHEREAS, Morgan Meyer was elected to serve the interests and values of his Republican constituents in Dallas County as their Republican Party of Texas nominee for State Representative, Texas House District 108, in the General Election of 2024;

WHEREAS, on January 7, 2025, Representative Morgan Meyer committed the following CENSURABLE ACT:

1. **He opposed Core Principle No. 5 of the Republican Party of Texas** defined in the Preamble of the Party Platform as “Personal accountability and responsibility” **by violating key Plank 213.a. of the 2024 Republican Party of Texas Platform,** which states:

“We oppose the use of pledge cards and call for Republican members to caucus after each November General Election to determine, by secure secret ballot, their candidate for Speaker and Speaker Pro Tempore.” [emphasis added]

Representative Meyer violated Plank 213.a. on January 7, 2025, when he violated the State Republican Executive Committee resolution passed on December 6, 2024, and the Republican Party Caucus Rules, by abandoning the Republican Caucus vote for Speaker of the House and, in an attempt to deny a quorum, met with the Texas House Democrat Caucus, which resulted in being able to secure an alternate candidate for Speaker by relying on Democrat support, as opposed to a Republican majority.

WHEREAS, on January 14, 2025, Representative Morgan Meyer committed the following CENSURABLE ACTS:

1. **He opposed Core Principle No. 5 of the Republican Party of Texas** defined in the Preamble of the Party Platform as “Personal accountability and responsibility” by violating key Plank 213.a. which states:

“We also call for Republican members to vote as a unified body for their selected Speaker and Speaker Pro Tempore candidate when the Legislature convenes in regular session, provided that the individual selected in caucus for speaker publicly pledges to comply with the entirety of this plank.” [emphasis added]

Representative Meyer violated Plank 213.a. on January 14, 2025, by not voting for the Republican Caucus Nominee for Speaker of the House, and instead voting for Dustin Burrows, who had not pledged to comply with the entirety of the plank.

2. **He violated the will of the people of District 108 represented by the Dallas County Executive Committee (CEC)** by ignoring the letter sent on January 7, 2025, demanding he “support the House Republican Caucus Nominee, Representative David Cook, for Speaker of the House”, as stated in Plank 213.a. above. (See Exhibit A – Dallas CEC Letter to Representative Meyer)
3. **He violated Principle No. 10 of the Republican Party of Texas** defined in the Preamble of the Party Platform as “Honoring all of those that serve and protect our freedom” by not honoring the will of the District 108 Precinct Chairs that serve and protect the freedom of the voters. (See Exhibit A – Dallas CEC Letter to Representative Meyer)

WHEREAS, on January 23, 2025, Representative Morgan Meyer committed the following CENSURABLE ACTS:

1. **He violated the voters’ rights in the Republican Party Preamble and Article 1 Section 2 of the Texas Constitution:** By imposing the “nuclear option” motion on the Texas House floor, which cut off any opportunity for amendments and any debate on the new rules, he violated the voters’ rights to proper representation through their elected State Representatives. This was an egregious act that disrespected the members of the Texas House of Representatives and millions of voters in Texas. Allowing deliberation is the bedrock of our republic. Not allowing deliberation is tyranny.
2. **He violated Legislative Priority No. 4 – No Democrat Chairs:** “The Republican-controlled Texas legislature shall end the practice of awarding committee chairmanships to Democrats and require all committees to be majority Republican.”

Representative Meyer circumvented the true intent of the Republican Party’s “No Democrat Chairs” Legislative Priority by voting in favor of **mandating the appointment of non-Republican committee Vice-Chairs**, with sweeping new powers as Co-Chairs, as per HR4, Rule 4, Sec. 4A:

“ADDITIONAL RESTRICTIONS. If, at the time the speaker announces the membership of standing committees, the members of the house of one political party constitute a majority of the membership of the house, the speaker shall designate a member of that party to serve as chair of each standing committee. The speaker shall not designate a member of that party to serve as vice-chair of a standing committee.” [emphasis added]

3. **He violated Texas Health and Safety Code Section 81B.002** by voting to mandate the committee members and public to wear masks to committee and subcommittee meetings.

WHEREAS, it shall be construed as Representative Morgan Meyer committing a separate additional CENSURABLE ACT for each committee Vice-Chair position awarded to a Democrat, each subcommittee Chair position awarded to a Democrat, and each committee or subcommittee that is not majority Republican for the current legislative session in opposition to “Legislative Priority No. 4 - No Democrat Chairs” adopted at the most recent State Convention as described in Rule No. 34(c).

THEREFORE BE IT RESOLVED, the Dallas County GOP Executive Committee recognizes the aforementioned violations as egregious acts and considered censurable offenses. Dallas County House District 108 Representative Morgan Meyer has deliberately gone against fellow members of the House of Representatives, against state law, against the Republican Party of Texas Preamble and Legislative Priority, and against the rights of the voters to proper representation;

BE IT FURTHER RESOLVED, that the Dallas County Republican Party CENSURES State Representative Morgan Meyer according to the process in Republican Party of Texas Rule 44.a “for **THREE (3) OR MORE ACTIONS** taken during the Officeholder’s current term in opposition to the core principles of the Republican Party of Texas defined in the Preamble of the Party Platform as described in Rule 43A or to the Legislative Priorities adopted at the most recent State Convention as described in Rule No. 34(c).” [emphasis added]

BE IT FURTHER RESOLVED, that this Resolution shall serve as a formal request to the State Republican Executive Committee of the Republican Party of Texas to censure State Representative Morgan Meyer by imposing all applicable penalties set forth in Rule 44 of the Republican Party of Texas Rules, including but not limited to refusing to accept any application from him for a place on the ballot of a Republican Primary Election for a period of twenty-four (24) months following adoption of the censure and imposition of said remedy;

BE IT FURTHER RESOLVED, that the Dallas County Republican Party shall execute all penalties imposed by the State Republican Executive Committee of the Republican Party of Texas;

BE IT FINALLY RESOLVED, that this resolution has been delivered to Morgan Meyer no less than 7 days prior to the February 17, 2025 County Executive Committee (CEC) Meeting, and after the final vote of the CEC it shall be delivered in its final voted upon executed version to the Republican leadership within the Texas House of Representatives, Governor Gregg Abbott, Lt. Governor Dan Patrick, Atty. General of Texas Ken Paxton, the Republican Party of Texas (RPT) Chair Abraham George, RPT Vice Chair D’rinda Randall, and be made available to the public for full transparency.

Dear Representatives Meyer and Button,

Chairman West and the undersigned Precinct Chairs of the Dallas County Republican Party are writing to express our concerns with you, our representatives, regarding the upcoming election of the Speaker of the Texas House of Representatives.

On December 7, 2024, the Texas House Republican Caucus met to nominate a candidate for Speaker. Following a thorough and fair process, the Caucus elected Representative David Cook of Tarrant County as its official nominee. Regrettably, you:

1. Disrupted this process by attempting to deny quorum by walking out prior to the third and final vote, and
2. Secured an alternative candidate relying on Democrat support, thereby violating Republican Caucus rules.

As your constituents in Dallas County, we demand that you unite with your Republican colleagues by publicly supporting the House Republican Caucus Nominee, Representative David Cook, and voting to elect him as Speaker of the House.

In the event you do not support Representative David Cook for Speaker or you vote for any attempt to change the rules to allow for a secret ballot, Dallas County Precinct Chairs shall:

1. Proceed with a vote of your censure with all applicable penalties imposed,
2. Immediately campaign against you, and
3. Actively seek your replacements.
