Ally Raskin made a motion to appoint new precinct chairs. Motion was second and passed.

Party Chairman Allen West swore in new Precinct Chairs.

## **Chairman Remarks:**

Texas is no longer a Hard RED state. The five largest urban population centers in Texas are no longer RED. Large corporations are moving to Texas and bringing out of state employees. Moving forward, Texans must encourage CEO's moving toTexas to hire Texas residents.

We must remain vigilant against the Islamization of Texas.

Two years ago 74% of Texans voted in favor of closed primaries. The Texas Secretary of State has countered sued in opposition to closed primaries.

The chair read an anonymous letter encouraging members of the Dallas County Republican Party to unite.

Chairman West announced that he would seek re-election for Dallas County Republican Party Chairman.

## Vice Chairman Remarks:

Resolutions made at Precinct Conventions can become laws, therefore it is important that precinct Chairs and their neighbors participate at Precinct Conventions and Senatorial District Conventions. The duties of the temporary chair of the Senatorial Districts were presented.

It was clarified that PC's determine when and where their Precinct Conventions are held.

Ally Raskin stated that the party needs to purchase more credits with Project Broadcast at the cost of \$15000.

## **Treasurer's Report:**

Fred Tate reported a cash balance of \$114,196 as of October 31. Report is filed with the minutes.

## **Executive Director:**

Dee Holly encouraged PC's to support the DCRP Gala. Preeti Malladi was recognized for her dedication to and hard work for Dallas County GOP.

Stan Woodard provided an update from the Hand Count Task Force. There is a need for funds and workers.

#### **New Business:**

Tami Brown Rodriguez made a motion that the body divide into Senatorial District groups, 2, 8, 12,16, and 23, for the purpose of electing the temporary SD chairs for the upcoming 2026 convention cycle. (Correction was made that SD 8 is no longer in Dallas County.). Motion was second. Floor was opened for debate with three spoke in favor and no one spoke in opposition to the motion. Tony Torres called the question and it was second. Motion passed by a standing vote.
