Chairman Remarks:

September 20, is the first day of Early Voting for the seventeen TX Constitutional Amendments. Dallas GOP sent out an email alert regarding the amendments. Precinct Chairs are charged with the task of emailing the Constitutional Amendment recommendations to constituents in their precincts.

The Dallas Chief of Police has refused to enforce the law regarding illegal immigrants. It is recommended that individuals write to the Dallas City Council to encourage the City of Dallas to participate in the 287(g) program (to work with U.S. Immigration and ICE). The Dallas County Elections Department administrator, Paul Adams, will not require background checks for election workers.

Tomorrow night, Sept. 21, is the Top Gun Shooting Event.

<u>Treasurer's Report:</u> Chairman West presented the report in the absence of Fred Tate. Total operation funds - \$104,306 Hand Count Fund - \$5,600

<u>Vice Chairman Remarks</u>: Dee Holly reported that an email has been sent to all Precinct Chairs regarding a ticket discount price for the December 6 holiday event.

Election Oversight Committee Report: Susan Cumby stated that election workers are still needed for Election Day, November 4. This is an odd # year/nonpartisan election enabling the Democrat Party to staff Early Voting locations with one Republican, the Alternate Judge. There is a need for Poll Watchers.

New Business: Roy Getting made a motion to have the SREC'sr report to the body how they voted at the recent SREC meeting regarding the censorship of Representatives Myers and Chin- Button. Motion was second. Floor was opened for debate with three speaking for and three speaking against. Three spoke in favor. Two spoke in opposition. Tony Torres called the question and it was second. Standing vote resulted in the motion passing. SREC Susan Fountain stated that she voted against the censure of Representatives Myers and Chin-Button.

Anna Nelson presented a letter for the Chair to read to the body.

Aju Mason announced a Candidate Petition Signing event at DCRP Headquarters on October 29 from 6:00 TO 8:00 p.m.

Question was raised regarding the appointment of temporary chairs for precinct conventions. Precinct conventions will be addressed at the November or January CEC meeting.

December 8 is the deadline for filing to be on the March ballot for precinct chair.

Mike Slaton reported that he and Donna Shelton participated in the L & A testing for E-Poll Books on Oct. 17 at 3:00 p.m. at the Election Department. They questioned the voter suspense list. Donna Shelton expressed concern regarding a new mail ballot surrender form.
